NOTIFICATION

In pursuance of Rule 4 of Order II of the Supreme Court Rules, 2013, Hon'ble the Chief Justice of India has directed that the Supreme Court will be closed for the annual Summer Vacation from Monday, 13th May, 2019 to Sunday, 30th June, 2019 (both days inclusive) and will re-open on Monday, 1st July , 2019.
