Mr. B.V.Balaram Das and Ms.Shashi Juneja, learned counsel accept notice on behalf of the Union of India and the State of Jammu and Kashmir respectively in the above-mentioned matters.

We direct the Union of India as also the State of Jammu & Kashmir to file their counter affidavits on or before 22.11.2019.

After hearing, it is agreed that the Union of India will take the responsibility of preparing a common compilation.
