O R D E R

Heard.

In order dated 06.03.2020, instead of 07.03.2020 the date shall be read as 24.03.2020. We direct that on 24.03.2020, the Law Minister/Secretary (Judicial) of the State of West Bengal shall meet the Chief Justice of the Calcutta High Court in the High Court premises before 12.00 noon with all the necessary record.

The Law Minister may also send the Secretary (Judicial) to meet the Chief Justice instead.

In case, the Law Minister or the Secretary (Judicial) fails to meet the Chief Justice on 24.03.2020, the Chief Justice shall be free to take any decision he considers appropriate in the matter.
